
Reducing residential flooding across Gentilly

Numerous residents of the Gentilly Resilience District have been expressing their gratitude for NORA's Community Adaptation Program (CAP) and the positive impact that it has had towards significantly decreasing the amount of flooding on their properties, and improving quality of life.

Ms. Elena Evans, whose project has recently been completed, used to experience routine flooding on her property around her driveway, and along the sides and rear of her home. Thanks to CAP, her property is now equipped with a new driveway and back patio made out of permeable pavers (designed to allow water to more easily filter into the ground instead of pond on top) and a new infiltration trench (also known as a "French drain," strategically placed along her property's perimeter to capture storm water runoff from her neighbor's property).
